

Foilboard Giveaway – Terms & Conditions (Australia)

1. Promoter

The promoter is Foilboard Australia Pty Ltd (ABN 97 007 144 363), 40 National Ave, Pakenham VIC 3810, Australia.

2. Eligibility

Entry is open to residents of Australia aged 18 years or over. Employees of Foilboard Australia Pty Ltd and their immediate families are not eligible to enter. Distributors and suppliers are eligible to participate. If there is a dispute regarding the identity of an entrant, the promoter reserves the right, in its sole discretion, to determine the identity of the entrant.

3. Competition Period

The competition commences at 9:00 AM AEST on 19th September 2025 and closes at 11:59 PM AEST on 7th November 2025. Entries received outside these dates will not be accepted.

4. How to Enter

To enter, participants must:

- Provide their contact details; and
- Upload clear images showing Foilboard insulation used in a project.

Each distinct project or application of Foilboard (for example, shed, underfloor, wall, or roof) may be submitted as a separate entry, provided each entry includes unique images. Entries cannot be submitted via Facebook likes, shares, or tagging — this competition is administered solely through the official entry form.

5. Prizes

There are three (3) prizes in total. Each prize is a \$500 Visa Gift Card (total prize pool value: \$1,500 inclusive of GST). Prizes are not transferable, exchangeable, or redeemable for cash. Prizes will be sent by registered post within 14 business days of winners being confirmed.

Winners will be chosen by Foilboard staff after the competition closes on 7 November 2025. Judging will be based on the clarity, quality, and suitability of the submitted images for showcasing Foilboard products in use.

If a winner cannot be contacted within seven (7) business days of notification, the prize may be awarded to the next best valid entry as determined by Foilboard staff.
